RULES AND REGULATIONS AGREEMENT FOR KARATE/MARTIAL ARTS STUDENTS

(Registrants who do not agree to the following terms will not be permitted to participate.)

- 1) A student should respect his/her instructors and school. Rules and regulations set by the school and/or instructors must be obeyed.
- 2) A student must always remember that Isshin Ryu is not a provocative sport. It should only be used for self defense and only when there is real danger to his/her health or life or to defend the weak. **A student of the school should NEVER provoke a fight.**
- 3) A student should consider everyone his/her equal, inside and outside the school; no matter what the individual's nationality, race, religion, or social background may be.
- 4) Tuition fees and membership fees should always be paid in advance and one month's notice given if leaving the school. Refund of paid fees cannot be made under any circumstances.

SPARRING RULES

- 1) Students engaging in sparring **must** wear the following protective equipment **at all times** while participating in sparring exercises and/or sparring practice: **Headgear, Mouth Piece, Cup (males), Chest Protector (females and children), Hand Pads, Foot Pads.**
- 2) Students **must** abide by the following rules while engaging in sparring and/or sparring exercises:
 - **NO facial contact**
 - **NO kicking below the belt**
 - **NO striking to the back**
 - **NO leg sweeps**
- 3) No students may engage in sparring or sparring exercises unless a Black Belt is present at all times during sparring and/or sparring exercises, and permission of the director of the Academy or the head instructor, Sensei Romney Taylor, has been given.

I have read (or have had read to me) and understand the above rules and regulations and I agree to abide by them. I further understand that if I break any of the above rules and/or any additional rules made by an authorized instructor, I will be required, at that time, to leave the Dojo. If I continue to break the rules I will be required to leave the school with no refund given.
